- A. Seller Representative call with Buyer and Representatives.
- B. Buyer submits CP/KYC/CIS + TSA/TSR/Barcode <u>or</u> CPA/Q88; Seller reviews.
- C. Seller and Buyer call to discuss transaction, define first lift and future contract.

1. Buyer issues ICPO with full banking, large scan Passport copy, scan copy of Company Certificate and full content of this procedure, unchanged. Buyer Company Profile shall be included in separate PDF not inside the ICPO. Buyer also includes Tank Storage Agreement, hereinafter called TSA, as proof of storage availability from a verifiable tank storage company.

2. Sending the ICPO means that Buyer accepts Seller procedure FOB-TTT as well the price!

3. After review, verification and approval, Seller issues commercial invoice, hereinafter called CI, for available quantity in the storage tank. Buyer must sign the CI and return to Seller within 48 (forty-eight) hours.

4. Seller issues statement of product availability, commitment letter to supply, and Unconditional Dip Test Authorization, hereinafter called UDTA, to be signed by Seller, Buyer, and Buyer's tank storage company.

5. Upon receipt of the signed UDTA letter, Seller issues the below documents to Buyer:

- 5a. Endorsed UDTA by both Seller, and Buyer's tank farm.
- 5b. Fresh SGS report issued to Buyer | Buyer's tank farm on Buyer's expense.
- 5c. Tank Storage Receipt, hereinafter called TSR.
- 5d. Authority to Verify, hereinafter called ATV, filled & endorsed and by Buyer's SGS dip test personnel & their passport copies.
- 5e. Authorization to Sell & Collect, hereinafter called ATSC.

6. Buyer conducts dip test in Seller's tanks and upon successful inspection, Seller commences injection of the product into Buyer's storage tank and issues the full Proof of Product, hereinafter called POP, documents to Buyer.

7. Buyer makes 100 % (one hundred percent) of the payment by SWIFT MT103/TT wire transfer for the total product value and Seller immediately transfers the Title of Ownership to Buyer. If SGS report meets Q&Q requirement, Buyer will within 24 (twenty-four) hours make the full payment, as provided in the CI, for the product via MT103 T/T Swift to the account specified by Seller. Buyer shall immediately send the Swift confirmation to Seller.

8. Buyer will have 5 (five) days, from the first full day Buyer is allowed by Seller, to inject into Buyer's tanks. If the product is not fully removed from Seller's tanks after 5 (five) days, Buyer shall pay USD 55.000 (Fifty-five thousand USD) per day until fully removed.

9. Seller issues a Sales and Purchase Agreement, hereinafter called SPA, to Buyer who will undersign for the Rolls and Extensions, hereinafter called R & E, to assure the weekly or monthly deliveries. The SPA will be issued by Seller within 1 (one) day after the CI is returned by Buyer to Seller.

10. Buyer, after approval of successful SGS and Q&Q report, will issue a Revolving Bank Guarantee, hereinafter called RBG, or a Standby Letter of Credit, hereinafter called SBLC, or Irrevocable Letter of Credit, hereinafter called IRDLC, non-transferable, auto-revolving and for the duration of the contract, in an amount to cover the next contract order and required estimated payment to Seller. This is based on the duration of the contract.

11. Buyer pays immediately after successful UDTA via MT103/TT on each contract delivery, within 3 (three) hours.

12. After the initial lift, any subsequent delivery shall commence according to the terms and conditions of the contract.

Buyer must integrate the full content of this procedure, unchanged, into ICPO.
